Hello Trevor

I am sending you this information as requested for you to view in your own time if you are interested.

I am very upset at James & Jannines actions as I can prove without doubt that none of there claims are true.

I did try to warn you in advance of what James would do and I was under the misapprehension that as our company lawyer you were there as a legal policeman to make sure things were done equally and fairly in the company, had I known this was not the case I would not have wasted all the time trying to mediate with James.

All I wanted was for things to be FAIR & EQUAL as they were previously.

I stated in my letter given to Gayle and faxed to you that all payments would need to be authorised by BOTH DIRECTORS and BOTH DIRECTORS SHOULD ONLY BE PAID THERE NORMAL SALARY. So everything is fair and equal.

James realised that because I had gone away he had full control of the bank account and that he could do what he wanted.

I have in my possession over 200 pages of written SKYPE conversations, I can show that James agreed with what was going on 100% I am quite happy so send you a shortened version for you to read the relevent parts or the full verion so you can read everything. James, Gayle Lisa and my self were in contact almost everyday, at no time does James say YOUR CHINESE COMPANY he and I even discussed the new company name so Adrad our competitor would not tie our companies together, it is all written down. James does not refer to this big argument we supposidly had until DEC 08 that was the first time I heard about it and I had been in China for 18 months.

James accusations that we must have sold products behind his back because the Chinese company has a web page on Alibaba trade site, is the same as me suggesting that James must have killed someone because he goes out with a gun and soldiers use guns to kill people. If we use that kind of logic the whole world would be in prison.

I have talked to a few members of staff and ex employees and the sad thing I learned was that they all discribed James as paranoid, he trusts no one.

Do you know James drinks between half and a full bottle of whiskey most nights and has been doing this for quite a while, paranoia is a symptom of alcaholism I am told.

James lost his temper at home when my mother was visiting and all the children were screaming and hiding under there beds.

Jannine showed my mother where James had punched holes in the house walls when he looses his temper and Jannine also told me after I returned at one time James threatened to kill them all. I am concerned because James has guns.

James issued a trespass order and a raft of TOTALLY FALSE accusations against both myself and Lisa and then has you dismissed as company lawyer because he knows that you are straight and honest and would always tell the truth.

I did not expect you to take sides I expected you to go straight down the middle and with the facts I have you can clearly see James was taking a huge amount out of the business compared with me and I was not happy.

At the time you and I met on our prearranged meeting on Tuesday morning James issued his statutory demands to you while in the factory at the same time he was telling all the employees that there jobs were safe, in his letter to me issued that morning he is stating he wants to liqudate the company.

James, Jannine and Gayle have so far colluded to remove \$114,000.00 from the company bank account to a Kiwibank in JANNINES name. The first payment was in a cheque (\$46500) written by Jannine and signed by Gayle (she would know there was no invoice or legal reason) the two subsequent payments were made by Gayle by internet transfer (No Legal reason) this is fraud.

James threat is to use money from his land to batter me legally so I will give in. I have done nothing wrong and I am prepared to put it in writing if you wish as my business and premisis as security. Lisa and I have always acted in the best interest of the company at all times even to the detriment of ourselves. James only acts in the interest of his own pocket since I left to go to Australia.

I am enclosing an afadavid which Andrew our foreman has written, he was so upset at what has gone on he asked me what he should do and I advised him to take independant legal advise and this is what he did. He has given me a copy today, I have not discussed with him what is in it he did this with his legal advisor and got it signed. This is PRIVATE and CONFIDENTIAL and for you only. Andrew has said he is happy to testify in court if it went that far.

I tried to avoid this situation and I truly believed that you were there to protect my interests as well as James, that is why I asked you if Matthew Gilligans threats were true and you advised me that you did not think it was possible. Now I find myself locked out of my own factory a security bodyguard on the gate and neither Lisa or myself getting paid.

I wish there was something you could do to help, if you are truly interested in helping us as you said your valuable advise may help the situation.

- 4 Trust Lease for factory.
