

Hello James

Thank you for your letter, It was very interesting to hear you say that Julian has SELECTIVELY given me information, when this is ALL you have ever done for the last 6 years and NEVER provided me with any documentation.

As for Julian giving me selective information this could not be further from the truth, yes I have read Trevor Quirke affidavit and it looks like a very convincing document if you read it solely on its own it looks quite damning but when I match it up with all Julian's recorded meetings with Trevor (yes he recorded all of you and the meetings with Trevor for quite a while before you illegally locked him out) Trevor's affidavit does not tell the truth.

I have seen about 10 other documents related to this so I do know what the truth is and it is not what you have been telling me. When you put it in context with your statutory demands it shows you staged the whole incident to make Julian look bad.

I know the reason Julian issued those letters warning the company about the statutory demands was because you phoned me and told me you were making threats of what you were going to do to Julian if he did not do things your way. I phoned Julian straight after you put the phone down and told him of the threats you made to me so I know Julian is telling the truth.

Please do not try to tell me because Trevor is a lawyer then he must be telling the truth, or because you got away without conviction that you are telling the truth, many lawyers are liars, who will say absolutely anything to get their client found not guilty or discharged whether they are guilty or not, they are highly paid for this.

We watched last week on TV a trial of a man who tried to suffocate a policeman who was in hospital, we saw him commit the act and then get caught in the act and then the trial were the criminal protested his innocence and a very clever barrister got him cleared of the crime and found not guilty, all I could think of after is how you keep telling me you are innocence but all the documents and paperwork CLEARLY SHOW YOU ARE GUILTY.

Julian was promised that he would be called to give a victim impact statement at your trial but he was not called. None of Julian's letters to the company accountant insisting on an audit were presented in court, none of his evidence was presented so you were able to convince the Judge this was a minor dispute and get off. Julian is about to make a big publicity claim about this in public and on the internet providing all his documentation and getting the Judge to explain why under one of the most severe documented conditions of shareholder oppression you were able to get away with a discharge.

Even without that the documentation is quite clear once I read your Satutory Demands for \$105,837.00 issued by you through your personal accountant dated 15th of September 2009 but only served on the company on the 29th September 2009 14 days later when you illegally lock Julian and Lisa out making false claims against them.

While all along you still claim you are negotiating with Julian in good faith but before any of these alleged problems with Julian took place while you are on holiday YOU HAVE ALREADY TAKEN LEGAL ACTION THROUGH YOUR Personal ACCOUNTANT Matthew Gilligan TO FORCE THE COMPANY INTO LIQUIDATION.

You blame Julian for all these things but you constantly lie and twist the truth, I have read all the documents, I know the TRUTH.

1 Please explain to me why you issued statutory demands to force the company into LIQUIDATION on the 15th of September 2009 but you only issued them to the company 14 days later when the documentation on the demands only gives the company 10 days after the served date to go to court to overturn the demand?

2 Please explain to me why you attended a meeting in good faith with Julian and the company lawyer to try and sort things out on the 16th September 2009 but you have already issued statutory demands to liquidate the company the day before on the 15th but neither the company lawyer or Julian knew about this?

You told me at that meeting you offered to sell Julian your shares but he refused to buy them making Julian look like the person who is difficult and uncooperative but you never explained to me WHY Julian would not buy your shares. Julian has explained his reasons and given all the documents he has, I believe what he had shown me is the truth, you have shown me nothing, but made false accusations.

Julian refused to buy your shares because you had been stealing scrap and selling company products for cash and hiding non tax deductible items in the company accounts (yes I have seen all the documents invoices and emails) so why would Julian buy your

You again have twisted Julian's honest actions to your false claims.

3 Please explain why would you try and sell Julian your shares in front of the company lawyer at the meeting in the lawyers office on the 16th September 2009 when you issued the documents to force the company into LIQUIDATION on the 15th one day before.

Julian has given me a free run of his house and extensive collection of documents for over 3 months before I came to my own sad conclusion that almost everything you have told me is a lie, a warped twisted version of your fictional truth not the TRUE FACTS.

I have seen all the emails , letters between Julian and you , I have seen 400 pages of Skype conversation between you Jannine Gayle Lisa and Julian as far back as Australia, about 2006.

I have read your lawyers letters(also the couple they found after you left Madras St were very interesting), Julian's lawyers letters,liquidators letters, liquidators lawyers letters receivers letters,letters from the Ministry of Economic Development who prosecuted you, company lawyer emails and documents, company bank accounts , Ace payroll documents and had full access to Julians accounts business and personal and anything information I wanted to read I have had free run of their house for almost 6 months and at least a month on my own.

Even the Laura money court case was a lie,I have read skype conversation 09/04/2009 where you says to Lisa " When you say I haven't lost anything 40 000 of inheritance went to Australia and I have not seen it since"

If you knew in 2009 your inheritance money went to Australia why did you sue Julian in 2011 claiming you did not know where this money went and that he hid it from you?

Julian and you both put your money in to setting up the Australia business Advanced Radiators , you were chairman I have seen documents signed by you, you both had 49% of the shares, how did you buy 49%, and find the money to establish Advanced radiators? The same way Julian did, with your share of the Laura money. Julian lost his money in Australia too.

Before Advanced radiators was setup you went to Australia to buy a radiator business called "Oil Cooler Care" in Makay from memory it was 2005 the price of the business was definitely \$200,000 (two hundred thousand) aud = \$215,000NZD if you did not know money was in Julians bank account then where was the \$215,000 NZD coming from to buy the Australian business?

Well it is quite simple as I see it , this was Julians money from Laura, your money from Laura and my share sent for the oven after the purchase fell through.

If you remove your share of the money because Julian supposedly hid it from you and you did not know where it was then there is nowhere near enough money to buy the business in Mackay for \$215,000 NZ so why do I have Wood Rivers Hawes Company accountants letters stating James is IN AUSTRALIA negotiating the purchase of the radiator company for \$200,000aud? and emails of correspondence from you and Jannine in Australia?

Why would Julian buy a business in Australia using his money and my money and you not putting in your share? This does not make any sense.

Its logical if you think about it, you knew the money was in Julians bank account there is no other explanation.

The company bank account was overdrawn, I have seen the statements, so the money did not come from there and you could not borrow more, so it can only have been Laura your money, Julian's money and my money?

4 Please explain why you brought the Laura claim against Julian when you knew you were in Australia trying to buy the business for \$215,000 NZ this is documented by Wood Rivers Hawes and you were there doing the negotiating.

You even used me your own mother to get out of the Laura court case, you said that I was the most important witness to your case and I was going to be forced to testify making me stressed and sick but you failed to mention that Julian did not need me to testify as he had lots of paper evidence in emails from you and Wood Rivers Hawes the company accountant proving you were in Australia trying to buy the business for \$215,000 NZ proving you knew where the money was all along. Had you gone ahead with the trial the Judge would be shown what a deceitful consummate liar you are and your losses would have been huge.

You put me under huge stress and strain with no concern for my health just so you could get out of your false claim at little cost to yourself.

5 Please give me a detailed explanation, if all the stories you have told me are true then why did you choose not to put your alleged honest case in front of a High Court judge at the liquidation hearing? , why did you give 75% of all the money to Julian when you are talking about \$400,000 + and then insist that the settlement is confidential? Why don't you want others to know the truth, if you are telling the truth, you have nothing to hide.

I have read your evidence and Julians in the bundle of documents that were prepared for the high court liquidation hearing,

3) Julians evidence and that of Sherry Maier of Strategic Pay Limited make your evidence look like it was written by a high school student, Sherry Maier had clear concise facts and figures and even states that Julian was working for Heatex in China a claim that you only started to claim was untrue after Julian and Lisa return from overseas and requested a company audit.

There is no prior evidence of your claim they were not working for Heatex until after Julian starts to question you about your theft and fraud from the family business.

I have read the Skype conversation and it is only when Julian starts to suspect that dishonesty is being committed by you do you start making the false claims about Julian and Lisa. I went to China and stayed with them and all they talked about was how they could help you and Heatex.

You also claim in your letter that " I told you that I could not carry on like that" and wanted Julian to come back and work as hard as you did"

First of all while I was in China Julian worked 6 days a week 8am to 7pm and Lisa worked the same hours 7 days a week, they worked, lived, ate and slept in the factory how were they not working hard like you? You only worked 5 days a week.

You claim that you asked Julian to come home and work but the Skype conversation I have read again does not match what you tell me.

A: I have seen no message in Skype telling Julian you have been rushed off to hospital in an ambulance from work. If it is that serious or true why has no one else heard of this or it is in Skype or email?

B: Julian offers to come back to NZ to work but you tell him that there is NO WORK FOR HIM and telling him to go back to Australia.

6 Please explain how Julian working in Australia takes the load off you in NZ?

In Skype conversation it is quite clear that Julian is concerned to find you help at Heatex but you find an excuse Everytime. You could have taken a cut in pay and hired another employee, Julian offered to do this but you chose money over your health. You chose money over your health and then you blame Julian.

With your income , Janine's income , the fuel you were claiming the phone bills you were claiming, the money taken from your directors loan account, the goods you were selling for cash, the scrap you were selling for cash you were getting close to \$200,000 but YOU STILL CHOSE MONEY OVER YOUR HEALTH and all you can do is blame Julian.

7 Please explain why you both pressurised me in 2009 to pay \$15000 for Holly's schooling when you told me you had no money?

I have looked at your wage slips, Ace payroll reports IRD tax payments and you and Jannine had a legal income of over \$150,000 that year plus all you phone bills internet, fuel, food you were charging illegally to work, directors loan account, plus the cash you were taking from selling company stock (yes Julian has emails from customers proving this) and scrap you were selling for cash, your total income must have be close to \$200,000 but you pressured me to forgo my loan repayments from Heatex so you could have this extra \$15,000 of my money, I told you numerous times that I was struggling to live on the small pension , I needed to make loan repayments etc, I am now almost 87 years old but you did not care about me or my problems all you wanted was my money.

I have just finished reading your sworn statement dated 13th June 2014 I counted at least 17 outright lies, example point 17 I did not agree with the plaintiff moving to China, I stayed with you and you never said such a thing against them working in China, If this was true like you claim why did you not write to them or the company lawyer to get them to return? Why did you send them all the money to setup the factory? I have read much of the Skype conversation, so again I know you are lying.

8 I want you to provide me with factual proof you did not agree with Julian and Lisa setting up in China for HESL.

I have also seen Julian's previous will, he had left the business which would have been worth multi millions seeing all the new products I have seen he has designed and made, everything was to go to you and your children, Lisa was only left personal effects ,some shares and the house to live in until she died, then the house which could have been worth millions at current growth rates went to Thomas and Holly. I hope you are proud of yourself, I do not know how you can look yourself in the mirror and keep telling yourself you did nothing wrong, you are a consummate liar.

I have just finished listening to lawyer Dean Kirkpatrick and the OA on the tape made into the investigation of your claims used as a reason to lock Julian and Lisa out, Julian provided me with the bundle of documents that you provided for the investigation and the bundles of documents they used for their defence. I am totally amazed you could make such false claims and it is quite clear you make up the whole thing just to lock Julian out from work, after listening to the investigation it is quite clear you would purger yourself for anything and you have no conscience or understanding of the word TRUTH.
